Econometrics (Undergraduate)

Taught in the academic years 2025/26, 2024/25, 2023/24, 2022/23, 2021/22

This course teaches bachelor students to apply econometric models for cross-sectional, longitudinal, and time series data to answer substantial research questions using the general-purpose statistical software package Stata. The focus is on determining economic associations among variables, performing statistical tests, and the economic interpretation and presentation of the results.

Inequality & Development (Graduate)

Taught in the academic year 2025/26, 2024/25, 2022/23

This course deals with the determinants and patterns of inequality, poverty and socio-economic development across the globe, with a major emphasis on the low- and middle-income countries of the Global South.

Economic Development (Undergraduate)

Taught in the academic years 2025/26, 2023/24, 2022/23

This course deals with the determinants and spatial patterns of economic and human development and inequality and the relationship between development and poverty and inequality. Two major questions addressed in the course are: (a) What are the major determinants of the growth of regions/countries? (b) How does the distribution of economic activity within and across countries and regions arise and develop?

Course material: *Policy, European Commission and (working) papers in economics*; ‘*Economic Development (13th edition)*’ by Todaro, M.P. & Smith, S.C. (2020), Pearson.

Current Issues in International Economics (Graduate)

Taught in the academic year 2021/22

This course offers the opportunity to delve deeper into specific issues relevant to development and international economics. The course provides a selection of recent (working) papers that will be presented and –importantly– critically discussed and reviewed.

Regression and Data Analysis (Graduate)

Taught in the academic years 2018/19, 2016/17, 2015/16, 2014/15, 2013/14, 2012/13

The course introduces students to the basic principles of classical regression analysis and discusses modern techniques of data analysis both as supplements to standard regression analysis and as stand-alone diagnostic tools. Hands on computer workshops are designed to familiarize students with the statistical package STATA.

Collecting and Evaluating Data (Graduate)

Taught in the academic years 2020/21, 2019/20, 2017/18

This course responds to the increasing demand for primary (micro-)data collection. Typically, courses on statistics and econometrics focus on estimation and model specification. This course is designed to deal with such blind spots and addresses the following issues: Survey design and sampling strategies, sample size, power calculations and minimum detectable effects, the use of sample weights, dealing with non-response and measurement error.

Principles of Economic Development – Microeconomics (Graduate)
